Water is pretty clear. Yesterday's Secchi reading of visibility was 54.3 feet, down about 10 feet from the weeks before - but prior to the drying-out period 6 weeks ago, it was 14 feet. Water color is still green from chlorophyll. Plant growth in the spring and river has gotten a boost; eel grasses have expanded quite a bit. Hydrilla is coming back, downriver and near Sally Ward. A lot of wildlife along the river. A least bittern was seen a few weeks ago, a rare sight. A lot of large alligators. One tour boat is operating, which

can hold at least 24 people. Bill Snowden of the Wakulla Sun rode along and Cal expects an article will be published soon.

Anthony had emailed to the Board two documents containing public comments responding to the draft ordinance. He said he'd read many of the comments and none suggested that the proposed ordinance went too far; most urged the County Commission

to do more.

Chad: WSA sent a short letter to the County Commission saying the draft ordinance doesn't go far enough, public workshops should be held, and the public comment period should be extended.

11:15 Tom made a motion to have Mike and Bob represent WSA at the May 1 County Commission meeting and present our issues, including that the ordinance should apply countywide, "hazardous wastes" should include petroleum products and they should all be stored aboveground, and the ordinance should further address discharges of nitrogen and other contaminants. Motion seconded by Brian and passed without opposition.

Cal stated that he'd attend the Commission meeting as well, to comment on the Tallahassee fertilizer inconsistency - though not as a representative of WSA.
