9:05 Anthony Gaudio called the meeting to order, asked those present to introduced themselves, and reviewed the agenda.

9:10 Financial report - Jim Davis

Brian Lupiani made the motion to approve the minutes, seconded by Tom Taylor and passed without objection.

9:12 Minutes of January 27, 2023, meeting - Brian Lupiani Because of the Secretary's late production of the January minutes, approval was postponed until the March 31 Board meeting.

9:15 Create a working Group to develop WSA's recommendations for Wakulla County Ballot Initiatives for the 2024 Election – Lynn Artz

Because Lynn Artz and Jim Davis both serve on the Wakulla County Charter Review Commission, Jim logged out of the meeting at this point to avoid any possible sunshine law problems.

Lynn described the charter review process and suggested that WSA establish a working group to propose springs protection language for the county charter. Charter proposals require 10 votes (out of the commission members present; there are a total of 15 members) to be approved and put directly on the ballot. The County Commission cannot alter the proposal. Lindsay asked if it was a genuine attempt to improve the Charter; Anthony replied that it seems sincere, since the proposals don't have to go through the County Commission.

Chad volunteered to be on a working group, if there's no conflict with his position on the Wakulla Planning Commission. Lindsay, Anthony, Mike, and Lynn also volunteered. Anthony asked about the time frame; Lynn thought it would be 2 or 3 months and noted that the Charter Review Commission meets on the first Tuesday of the month.

9:45 The WSA Board approved a motion (by Brian, seconded by Gail) to create a working group to develop WSA's recommendations for Wakulla County Ballot Initiatives for the 2024 Election. The working group will consist of Anthony Gaudio , Chad Hanson, Mike Keys, and Lindsay Stevens (along with Lynn Artz), with Anthony authorized to appoint others. The target date for proposals is April 28. The motion passed without objection.

At this point Lynn left the meeting and Jim Davis was notified that he could rejoin.

9:50 Florida springs 2023 legislative update (and more)- Ryan Smart, FSC Ryan Smart was not able to attend the meeting, so there was no update.

9:55 Springshed and river update - Cal Jamison

Cal mentioned that the visibility was quite low in the Spring, but on the bright side the underwater vegetation and fish appear to be making a comeback. He also gave a quick overview of the cave exploration recently done by Dr Bob Ballard and his team.

10:00 Cave exploration updates – The big connection! - Werner / Hagberg Chris Werner was not available to attend the meeting, so there was no update on the recent cave exploration discovering the connection between Chip's Hole and Wakulla Spring.

10:05 Draft Wakulla Ordinance updating the Springs Protection Ordinance regarding underground storage tanks – draft to be released 01/27, public comment until 02/08 – Chad Hanson providing commentary and context

Chad reported that there has been no word from Wakulla County regarding the draft ordinance for spring springs protection. He would like more WSA people to help review the ordinance once a draft is released

Is unrelated to current status of plans for a Wakulla Springs symposium for the public and elected officials probably sometime in late April or early May.
